Role of Internal Complaints Committee (ICC):

- ❖ The members of the committee shall organize programmes / workshops for the Faculty and students of the campus to sensitize them and to ensure knowledge & awareness about POSH Act and as well as responsibilities.
- ❖ The Committee shall act decisively against all gender-based violence perpetrated against employees and students of all sexes recognizing that primarily women students and employees and male students and students of third-gender, who are vulnerable to sexual harassment / humiliation and exploitation.
- ❖ The Committee shall receive complaints from the victim / aggrieved person and enquiry may be conducted by inviting all the members of the Committee. The report of the committee shall be submitted to the Executive Authority of the respective HEI and same shall be disposed within the permissible length of time.
- ❖ The Member Secretary shall involve in all kinds of proceedings of ICC and shall also ensure the compliance of laid down procedures by the statuary bodies such as AICTE / UGC / State / Central Agencies.
- ❖ In general, the term os office of the members of ICC shall be for a period of three years.
- ❖ No Honorarium / Remuneration would be paid to the members of the committee for taking this assignment, in addition to their regular monthly salary / allowances.
- ❖ The external member(s) deputed in the committee are eligible to draw TA/DA expenses as per State Government / University norms, as and when the committee meetings are conducted under physical mode either at the campus of the UCE Kancheepuram or any other appropriate place, as it may deemed to be fit for the committee.
